Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 1. Quality of education provided

Paragraph 2(1), 2(1)(a), 2(1)(b), 2(1)(b)(i)

- At the time of the previous inspection in January 2023, the school did not have a curriculum that was well planned and sequenced in all subjects. Pupils did not learn information in a well-ordered or connected way. Staff did not make precise checks on how well pupils made progress through the curriculum. In addition, the school's careers programme was not having a positive impact on pupils.
- Since that time, the school has set about improving the quality of the curriculum. In September 2023, leaders introduced new schemes of work in many subjects, including mathematics and English. These schemes of work are suitably specific about the component knowledge that pupils are expected to know and remember. This means that pupils build their knowledge in a logical order, step by step. However, the revised curriculum remains in the very early stages of implementation. The school is aware that there is more to do to embed changes and improve the quality of education provided by the school.
- The school is developing adults' expertise in finding out what pupils know and remember. As part of this work, the school has introduced a new approach to assessing pupils' progress through the curriculum. This approach includes adults making more precise checks on pupils' knowledge. However, staff are in the early stages of teaching revised curriculum content, and their work to check pupils' understanding is also in its infancy. The school is not yet clear about the impact the curriculum is having on what pupils know and remember.
- Leaders have made positive changes to improve the quality of careers guidance provided for pupils. They have made deliberate links between the school's academic curriculum and opportunities to promote pupils' understanding of commerce and business enterprise. In addition, the school has recently adopted a new careers curriculum. This curriculum is in the early stages of being introduced and has not yet fully impacted as leaders expect.



■ The independent school standards (the standards) in this part are not met.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1), 34(1)(a), 34(1)(b)

- At the time of the previous inspection, the proprietor body and leaders had not ensured that all of the standards were met. There were weaknesses in the quality of education provided. The school's curriculum was not well planned or sequenced in all subjects.
- The proprietor body and the new headteacher have a clear and ambitious vision for the school. They have strengthened structures of leadership, accountability and reporting in order to maintain oversight of their statutory duties. Proprietors now gather more useful information about the quality of the school's curriculum and its impact. This information is beginning to provide leaders with an emerging view of the quality of education at the school.
- Leaders have taken steps to improve the quality of the school's curriculum. These steps have included the adoption of commercial schemes of work in many subjects. The school is now beginning to monitor how effectively the curriculum is implemented and its impact on pupils' learning. Leaders' actions are beginning to make a positive difference, but there is still much to do. Many changes have been introduced very recently. The school is not yet able to demonstrate that all of the standards are consistently met.
- The standards in this part are not met.

Information about this school

- The Fitzroy Academy is an independent residential special school that caters for pupils with a range of special educational needs and/or disabilities, including autism, learning disabilities, and associated social, emotional and mental health needs. All pupils have an education, health and care plan.
- The school is registered to admit up to 40 pupils.
- The school does not use alternative provision.
- A new headteacher started at the school in June 2023.



Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous standard inspection in February 2023. This was the school's first progress monitoring inspection.
- After the previous inspection, the Department for Education required the school to prepare an action plan. This action plan was judged to be acceptable on 30 May 2023.
- The inspector held discussions with school leaders and the chair of the proprietor board to review the progress made against the previously unmet independent school standards.
- The inspector spoke to staff who teach the curriculum and held some informal conversations with pupils to find out about their experiences at the school.
- The inspector reviewed curriculum policies and schemes of work. He also visited lessons and reviewed a sample of pupils' work.
- The inspector held a meeting with the leader responsible for safeguarding. He also reviewed the single central record of checks made about the suitability of adults.
- This inspection was conducted without notice.
